Artists may submit up to five images for jurying. These images must be representative of the work you typically produce. Images are for jurying purposes only and will not be required to hang in the show.

Images should be labeled as follows: Artist last name.Title.Medium

Provide a brief biography describing your work, awards, shows participated in and galleries featuring your work.
