Current issues:

- ROMP (Recreation in the Outdoor Management Program) v. passive enjoyment of Open Space lands
  - Managing access points for river rafting.
  - Managing trails use, hiking v. biking
- Trails Partnership Program proposal for Greenway development
- Argo Project (Idaho Springs) is moving forward (downhill mountain biking)
  - Working with RTD to establish a shuttle, parking in Idaho Springs is very limited
- OHV/ORV use on CCC Open Space lands, highly contentious
  - National Forest & BLM lands OHV/ORV must be registered with CPW, must display registration sticker, can only operate on designated roads or trails
  - Colorado Revised Statute 33-14.5-108, cannot operate ATV/OHV on any public roadway, highway or street in Colorado except in an emergency situation or for agricultural purposes, unless there are signs designating otherwise.
