McDermand Ranch permanently protected (Oct 2nd, 2023). Colorado Open Land, Gunnison Ranchland Conservation Legacy, and the Gunnison Valley Land Preservation Fund have come together to preserve and protect a 572-acre ranch in the Ohio Creek Valley.

In 2018, the McDermand Ranch landowner purchased an adjacent 422 acres with the intent of removing a planned subdivision from the land and protecting the land forever. The McDermand Ranch is habitat for big game (elk, mule deer, moose, bear and mountain lions) and several Colorado Species of Special Concern (Gunnison sage grouse, bald eagle, ferruginous hawk, sandhill crane, and the northern leopard frog). It's mostly irrigated meadows and a mile plus of Ohio Creek frontage. Currently the land is used for hay and grazing, and is a valuable addition to the network of conserved and public lands within the scenic Ohio Creek Valley.

Keep It Colorado Receives \$1 Million From Great Outdoors Colorado. 9/22/23, GOCO's Board approved the second installment of a three-year, \$3M investment in conservation initiatives supported by Keep It Colorado. KIC plants to use the investment to advance on-the-ground projects to protect lands through conservation efforts, demonstrate the economic return on investment of conservation, and grow land trusts' capacity to engage more people in conservation while reflecting the multifaceted interests of Colorado's diverse communities.

Continue meetings with Kay Axtell (SOLVE) to mentor SOLVE and Clear Creek County Open Space.

SOLVE is taking a firm stand against the use of OHV (off-highway vehicles) in any of the CCC Open Space parks, based on perspectives and lessons learned from surrounding counties.

SOLVE is joining with MALT to fund-raise for a conservation easement on the Floyd Hill Meadow, the 18.5 acre property that was recently donated to CCCOS by Albert Frei. PLAN Jeffco engaged with SOLVE and others to save the Floyd Hill Meadow from commercial development back in the early 2000s. Sometimes it takes a while to get things done.

Recreation Activity Impact:

- Batch plant assembly and testing is ongoing.
- Osprey Point boat launch and South Boulder Creek Inlet Trailhead.
- South Shore and Windy Point picnic and fishing areas.
- Areas open during the construction project:

- · North Shore Picnic Area, boat ramp and parking lot at the intersection of Gross Dam and Flagstaff roads.
- South Boulder Creek Outlet Trail below the dam. (Intermittent closures are possible during days with road restrictions on Gross Dam Road near the dam.)
- · Winiger Ridge Campground. (The campground is typically open mid-May through October. Some temporary closures are expected starting in 2025.)
- Forsythe Canyon Trailhead hiking. (Some temporary closures are expected starting in 2025.)

Current Work Activities:

- Onsite crusher and batch plant testing began in September 2023.
- · Crusher plant operation is underway.
- · Batch plant assembly and testing is ongoing.
- A temporary batch plant is located at the base of the dam and produces concrete for dam foundation preparation.
- · Quarry development continues, which will create rocks and sand for concrete production.
- Construction site development is ongoing.
- Drilling and blasting activities support site development, dam foundation preparation and quarry excavation.
- Dam foundation preparation is creating a stable base for the expanded dam. This is separate from the main dam structure.
- Dam face preparation is using ultra high-pressure water to remove the top layer of the dam face.
- Nighttime hauling continues between where Gross Dam Road crosses South Boulder Creek and the T-intersection by Gross Reservoir Headquarters. From 6 p.m. to 5 a.m., Monday through Saturday, flaggers will direct traffic through the area.
- Roadway improvements on Gross Dam Road began in March 2023.

Completed Work:

Intersection improvements at Highway 72 and Gross Dam Road began in February 2023. The new intersection alignment was opened on June 26.
