What's been happening at the Open Space Advisory Committee (OSAC) meetings...

May 2, 2024, in-office meeting

Information Item: OSAC Planning Workshops, to be held at the Officers Club, Camp George West, Pleasant View Community Park, on-going for the next 4-5 years, perhaps longer.

Action Item: Green Energy Initiative -EV Charging Station Projects, Resolution #24-05. Subordinating the reverter clause for the area upon which the EV chargers rest, since EV chargers are not for "recreation purposes". Motion to approve, seconded, unanimously approved.

Action Item: Apex Park & Recreation District - Cooper Land Conservation Partnership Program JCOS24-05, Resolution#24-06. Residential property at

1330 West 72nd Avenue, 2.47 acres, Apex Park & Rec District grant request. Purchase price \$2.1M, \$1M JCOS contribution, subject to Open Space reverter. Motion to approve, seconded, subsequent discussion, unanimously approved.

Action Item: Meyer Ranch Bossman Trail Easement, Resolution #24-07. Realignment of existing trail, 20 years in the making. Motion to approve, seconded, unanimously approved.

Action Item: Van Bibber Greenway -Fassel Agreement JCOS24-04, Resolution

#24-03. Horse boarding facility has encroached on Van Bibber Greenway, will be licensed to cross over the greenway to a grazing area on the north. Motion to approve, seconded, unanimously approved.

Action Item: Kittredge Park - Dlin Land Exchange JCOS24-01, Resolution #24-08. Proposed land exchange. Motion to approve, seconded, unanimously approved.

Action Item: Centennial Cone Park -Harkwood Trail LLC Properties JCOS24-09, Resolution #24-10. New acquisition, 122 acres of Goltra Property adjacent to Centennial Cone. Private property to the east will require an access easement. \$1.35M. Motion to approve, seconded, unanimously approved.

Jeffco Open Space Seasonal Wildlife Closures Begins February 1st: Each year Jeffco Open Space uses seasonal wildlife closures at the parks to protect species at sensitive times in their life cycles. Clear Creek Canyon Huntsman Segment Viaduct is starting to take shape. In early April Clear Creek Canyon was closed down so that a 190-ton crane could set the first 17 of 89 vertical beams in place. The beams will support the viaduct, which will eventually become the P2P Trail.

Elk Meadow, Lewis Ridge Trailhead is getting a facelift. The Park Construction Team has installed a new park trailhead sign and a new kiosk by the bathrooms. County Road & Bridge is making improvements to the parking lot, increasing capacity and improving drainage. Improvements are expected to continue into 2025.

Lair o'the Bear was closed earlier this month for annual repairs. The Park Services team did some cutting and chipping in the picnic areas and installed a trash receptacle on the east side of the picnic area. Two parking stops that were damaged during snow removal were replaced.

Alderfer/Three Sisters west trailhead was closed earlier this month for repairs.

Meyer Ranch trailhead was enhanced with gravel surface maintenance and other repairs earlier this month, in preparation for the summer rush.

Pine Valley Ranch, Narrow Gage Slabs are benefiting from the work being done by the JCOS Trails Team and the Boulder Climbing Community trails team, as the staging area retaining wall and base area/access trail junction of the lower staircase take shape.

Flying J Ranch was closed for a short time on May 6th due to a small wildfire. High winds brought a tree in contact with a power line, catching the tree on fire. Jeffco Sheriff, Elk Creek Fire Protection District and JCOS Park Rangers quickly arrived on scene and extinguished the fire before the fire was able to gain ground. The JCOS Natural Resources Team had done some extensive fire mitigation work a few years ago, which contributed substantially to being able to arrest this wildfire before it could get out of control.

Open Space Wildland Fire Team (OSWFT) participated in a prescribed burn activity in the town of Eagle, CO in April. This multi-agency team worked for three days and burned over 100 acres. One of OSWFT's tasks was to protect a red-tailed hawk's nest in a group of burning cottonwood trees, which they did. The tree and the nest were saved, and the hawks came back to the nest after the fire died down.

Quarry expansion is in progress. Frei family purchased the Floyd Hill Meadow (39.71893342699002, -105.40651944877656) and deeded it to MALT. MALT has started a fund-raising campaign for the costs of a conservation easement; Colorado Open Lands will hold the CE.

The U.S. Army Corps of Engineers and the Colorado Water Conservation Board are conducting a feasibility study about making changes to increase water storage and reservoir size at Bear Creek Reservoir in Bear Creek Lake Park.
