Clear Creek Canyon Park - Huntsman Segment - Construction Update 9.19.2024 (video)

Jeff Hoge, Construction Manager, gives an update on the Huntsman segment of the Clear Creek Canyon trail. This 3-mile segment of ADA compliant trail will connect the west side of Tunnel 1 to Huntsman Gulch. It will include seven new bridges spanning Clear Creek, one new bridge over US Highway 6, one new underpass beneath US Highway 6, multiple creek access points, as well as two new trailheads with full amenities and parking for approximately 100 vehicles. Construction broke ground in July 2022 and is expected to open to the public in 2025.

What's been happening at the Open Space Advisory Committee (OSAC) meetings...

Alternate month meetings are in the field. We have been assured that these inthe-field meetings are open to the public; the times and locations should be published on the County calendar.

Thursday, September 5. 2024, 6PM. Ponderosa Room, Jeffco Open Space, 700 Jefferson County Pkwy, Golden.

Information Item: Overview and Timeline of the Resident Survey. Rachel Brenna presented the proposed questionnaire which will be sent out to 10,000 Jefferson County residents in the near future for OSAC review.

Action Item: Evergreen Park & Recreation District, Deed of Kittredge Park JCOSD24-13, Resolution #24-15. Hillary Merritt described the finalization of the Kittridge Community Park property survey surrounding Bear Creek. Public areas are now to the north of the Creek, private properties to the south.

Action Item: Lookout Mountain Preserve – Public Service Company EV Charging Station Easement JCOS24-14, Resolution #24-16. Hillary Merritt described the agreement between JCOS and PSCo regarding installation of public EV charging stations near the Nature Center. PSCo plus a grant will pay for over half the cost for installation. JCOS must grant the easement in perpetuity and guarantee at least four charging stations. After 5 years the agreement will be evaluated.

PSCo Construction Allowance \$19,000 Charge Ahead Colorado Grant \$25,000 JCOS Contribution \$21,000 Total Cost – Equipment & Installation \$65,000

Jeffco Open Space Construction Updates

Quarry Fire Suppression Repair. The Quarry fire was declared contained in August, but the aftermath continues. JCOS Trails, Park Services, and Natural Resources teams have been working to repair the large disturbances that were created while fighting the fire in Deer Creek Open Space Park. Repairs include slope and soil stabilization, erosion control (matting and mulching), native seeding, riparian channel repair, and rebuilding trails. Repair and recovery will continue through the rest of the year into 2025, to include (but not limited to) targeted native plantings while monitoring the recovery of the area. South Valley and Hildebrand parks have reopened, but the Rattlesnake Gulch and Black Bear trails remain closed while JCOS continues to assess the damage and develop repair plans.

Elk Meadow Stagecoach Trailhead. The Stagecoach trailhead is being rebuilt. The work is being done by Western States Reclamation and their subcontractors. On the to-do list is an expanded parking lot, updated amenities, new centrally located restrooms, an enhanced road crossing, and restoration of low-use and closed areas near the trailhead. This work is expected to extend through the summer of 2025. In the meantime, the Lewis Ridge Trailhead will be the primary entry point into the park.

Trails Stewardship Team Wrapup. The 2024 season was a good one for this year's TST group. During the summer, they managed to complete a variety of projects in

multiple locations:

• Hildebrand Ranch, finished 2 miles of tread, enhancing trail usability and sustainability for all users;

Crown Hill Wildlife Area, undertook 0.7 miles of tread clean-up and corridor clearing, ensuring the trail remains safe and inviting;

 Lookout Mountain, a total of 0.3 miles of new trail was constructed, providing a sustainable path between the North Launch and South Launch for paragliders and hang gliders, plus 0.9 miles of undesignated trail were closed to protect natural resources;

Lair O' the Bear Park, successfully closed 1,100 feet of undesignated trail, helping to preserve the natural habitat and reduce the impact on the ecosystem;

South Table Mountain Park, Lava Loop Trail, cleared vegetation from 2 miles of tread, maintaining the trail's condition and improving the user experience;

Black Bear Trail, cleared 4.5 miles of tread of vegetation after the raptor nesting closure was lifted;

• Lakewood Open Space, in a critical fire mitigation effort, the team treated 2.16 acres, creating nearly a mile of a 20-foot buffer to reduce wildfire risks and protect the surrounding community.

The Trails Stewardship Team program is one of the better community programs sponsored by JCOS. It teaches teens about conservation, strengthening the commitment to preserving and enhancing the natural beauty and usability of our public lands.

Gateway Trailhead, Clear Creek Trail was the location for a first-in-Colorado featured stop on the National Engineering & Public Works Roadshow – a national event hosted jointly by American Council of Engineering Companies (ACEC), The American Public Works Association (APWA), and the American Society of Civil Engineers (ASCE). The Gateway Trailhead, and specifically the Peaks to Plains Trail, were selected to celebrate the complexity of design and the impact engineers have on communities and quality of life issues for the public.

Snow Removal Preparedness starts now. This is Colorado; it's never easy to predict when the first snow of the year will fall. Right now, La Niña appears to be building, which might mean we're in for a wet and cold winter in most U.S. locations. Nonetheless, the JCOS field staff will be doing their best to keep our trailheads, facilities and paved trails accessible and safe during snowy weather. If you're intent on hiking when there's snow and ice on the trails, don't forget to bring your crampons – or snowshoes, depending on the snow depth!

South Table Mountain Trail rerouting. Our fabulous Volunteers, managed by the JCOS Trails Team, spent the better part of this summer constructing a reroute of the "To Fossil" trail. The rerouting better aligned the trail with the slope of the mountain and set up a better connection to the T-Rex Tooth trail. Kudos to our Volunteers!

Lookout Mountain Nighttime Closures. Changes are coming to one of the Front Range's most scenic roads. Jefferson County officials will soon close Lookout Mountain Road at night. Jefferson County Open Space is making progress on new automated night-time gates that will close the road beginning Nov. 11. The four-mile stretch of Lookout Mountain Road will be closed on the east [downhill] side, up the road from Golden, at the Chimney Gulch Trail pullout. The west [uphill] gate will be around Lookout Mountain Park, [near] the Buffalo Bill Museum.

Flying J Preble's Meadow Jumping Mouse* Inventory. The JCOS Natural Resources team spent time at Flying J Ranch, inventorying the jumping mice who inhabit this area. This was a follow-up to a 2001 study, which found 40 jumping mice on the property. At that time, it was impossible to positively determine if the 40 mice were all Preble's, or if some of them were Western jumping mice (who knew there were two types of jumping mice in our parks?). This time, using poop and DNA, the NR team will be able to positively confirm who is who of the 16 jumping mice captured. In addition to jumping mice, the NR team caught deer mice, montane voles, house mice, meadow voles, and one very spicy short-tailed weasel, aka ermine.

* The Preble's meadow jumping mouse is on the List of Endangered and Threatened Wildlife under The U.S. Fish and Wildlife Service. Critical habitat for the Preble's mouse includes approximately 411 miles of rivers and streams and 34,935 acres of lands in Colorado.

Seed Collection Season. The JCOS Natural Resources team has been busy with

seed collections; they hosted 8 collections this year, utilizing staff, Volunteers, and even partnering with the City of Boulder Open Space and Mountain Parks (OSMP) staff. Collected seed is cleaned and then grown into plant stock which is used on future restoration projects.

Conifer Cone Collection Workshop. The JCOS Natural Resources team is developing advanced methods of seed collecting from our Front Range conifer species. They attended a collaborative workshop with Boulder County, Denver Mountain Parks, CSU Extension, the Nature Conservancy, the Colorado Forest Restoration Institute, and New Mexico Highlands University. Topics included beginning how to set up a conifer cone collection plan, strategy and capacity, and how to successfully plan and implement conifer cone collections. Colorado, specifically the Front Range, is lacking is seed supplies for reforestation efforts following wildfires; JCOS hopes to shrink that gap.

Mountain Bike Courtesy Efforts. No one likes a rude mountain biker, least of all JCOS. With the assistance of various high school coaches, the JCOS Park Permit team and some of the JCOS Rangers implemented a trail and safety orientation for student athletes. This program aims to ensure that these young riders are not only excellent stewards of the parks but also safe and courteous with all visitors. Those who have completed the orientation are identified by a light blue card (credit card size) attached to the bike.

Volunteer BBQ Celebration. The annual end-of-summer Volunteer Picnic was a hit, despite the rain, which was welcomed by everyone who had been concerned about the very dry days preceding the event. The picnic shelter was filled with contented Volunteers who feasted on foods cooked and delivered by JCOS staff. Toward the end of the afternoon, the rain gave way to a double rainbow, as everyone lined up at the ice cream truck for dessert.

Garden Work at Boettcher Mansion. JCOS Trails team, comprised of nine Trails Volunteers, joined Boettcher Mansion's regular Gardener Volunteers to dig up overgrown weeds and grasses from a garden bed and get it prepped for planting next spring. Additionally, they were able to move existing rocks from the property to the garden; they are now showcase pieces. Charles Boettcher would have been proud of this team for re-using existing materials found on the mountain in a new and beautiful way; exactly what he did with many of the local granite rocks used to build the historic mansion walls in 1917.

New Tiger Salamander Population. Alderfer/Three Sisters was the location where a western tiger salamander, the Colorado State amphibian and the only salamander species known to occur within the State of Colorado, was found. While western tiger salamanders have been found elsewhere, this was the first vouchered record of the species in the park. This salamander, a juvenile, had recently completed its metamorphosis from an aquatic larva, and will probably remain at or near its natal wetland. In time, it may migrate to an upland area to forage for worms and insects. The adult tiger salamander will spend most of its time underground, living in "borrowed" burrows or digging their own.

Buffalo Bill Days Parade. Saturday, July 27th, JCOS staff and 9 Volunteers marched down Washington Avenue to celebrate Golden's Buffalo Bill Days.

Carnation Festival Parade. Saturday, August 10th, JCOS staff and Volunteers marched down 38th Avenue to celebrate Wheat Ridge's Carnation Festival, winning an award in the process.

Arvada Harvest Festival Parade. Saturday, September 7th, 11 Volunteer park hosts joined JCOS staffers to march in the parade and to share stewardship messages with festival attendees post-parade. Cheers to our Open Space Volunteers, who provide so much people power to JCOS.

Denver Water is in the process of transferring 45 miles of the 71-mile-long High Line Canal to Arapahoe County. The canal winds through 11 jurisdictions, from Waterton Canyon in Douglas County to northeast Aurora. The High Line Canal Conservancy, formed in 2014 to protect the canal, will hold the conservation easement for the 45 miles given to Arapahoe County, ensuring that the canal will be maintained as an open space park and trail, and will never be developed.

In 1972, PLAN Jeffco launched the citizen's initiative which created the Jeffco Open Space Program, protecting more than 70,000 acres comprising 27 parks and more than 270 miles of trails.
