PLAN Jeffco authored the "<u>Open Space Resolution</u>" ballot initiative in 1972 that provided a one-half percent sales tax in Jefferson County to establish the awardwinning Jefferson County Open Space program.

#### **Jeffco Open Space Construction Updates**

Alderfer/Three Sisters Homestead Trail. After the forestry work was completed at Alderfer, a few trails, including Homestead, needed repairs and re-routing. The Trails Team rehabbed the Homestead Trail, which reopened on September 28.

Boettcher Mansion. Boettcher recently hosted a volunteer project, led by Assistant Trails Volunteer Coordinator, nine volunteers, and Boettcher Mansion's regular Gardener Volunteers. Together, they were able to dig up overgrown weeds and grasses from a garden bed and get it prepped for planting next spring. Additionally, they were able to move existing rocks from the property to the garden to have them now as showcase pieces. Charles Boettcher would have been proud of this team for re-using existing items found on the mountain in a new and beautiful way; exactly what he did with many of the local granite rocks used to build the historic mansion walls in

Elk Meadow Stagecoach Trailhead. Construction on the Elk Meadow Park Stagecoach Trailhead has begun and is expected to continue through Summer 2025. Western States Reclamation and their subcontractors will be hard at work making improvements including an expanded parking lot, updated amenities, a new centrally located restroom, enhanced road crossing, and restoration of low-use and closed areas. During the construction closure, the Lewis Ridge Trailhead will provide primary access to the park. Once re-opened, the Stagecoach Trailhead will also provide access to a new trail experience on the south side of Stagecoach Boulevard to Jenkins Peak.

Meyer Ranch. Starting October 28, Meyer Ranch Park will be CLOSED for culvert replacements. The repairs are slated to last 30 days. The Park will be closed during this construction; this includes neighborhood access. Restrooms will be locked and will not be serviced. The double culvert replacements are on the entry road from the main parking lot into the park.

Mount Glennon. Starting October 14, bridge repair over Soda Lakes Road will begin with the mobilization of necessary equipment and material. Actual repairs will begin on October 21, with repair work slated to last until mid-January 2025. Impacts to visitors will be significant, including but not limited to a one-lane road, flagger-controlled, with reduced parking because of materials and equipment staging.

#### **Jeffco Open Space Science & Social Events**

National Public Lands Day Results. On Saturday, September 28, 412 amazing volunteers came out to 11 projects sites throughout Jefferson County. These enthusiastic individuals were able to collect 5,915 pounds of trash, seed 9,900 square feet of land, plant 2,300 native shrubs and perennials, remove acres of noxious weeds, and recycle 1,715 pounds of material. A HUGE shoutout to Volunteer Services, Natural Resources, Trails, Park Services, Community Connections, and the Ranger Teams for their remarkable assistance in creating a truly incredible community event.

Flying J Preble's Meadow Jumping Mouse Results please. Following up on last month's newsletter article about the work the Natural Resources team's study on jumping mice, it turns out that they caught zero Preble's this year. All the collected DNA samples were of high enough quality to test, and all trapped animals were identified as the western jumping mouse, Zapus princeps, and not Zapus hudsonius preblei, the Preble's jumping mouse. While the Preble's is on the List of Endangered and Threatened Wildlife (U.S. Fish & Wildlife Service), the western jumping mouse is not. All the results are shared with the U.S. Fish and Wildlife Service (USFWS) and Colorado Parks and Wildlife. The USFWS monitors the results of any Preble's surveys and restoration efforts across the species' range. The long-term goal of listing under the Endangered Species Act is recovering the species to the point that it can be removed from the Endangered and Threatened species list.

REI Kids' Co-op: Explore the Parks Event. On September 7, at the REI's Kid's Co-p Event, JCOS team members had a fantastic time engaging with the community. Staff historians, the resident archaeologist, and volunteers showcased a variety of artifacts, including a T-rex tooth from South Table Mountain Park and Native American artifacts

from a few of our other parks (Crown Hill & Pine Valley Ranch Parks). The highlight for the kids was the "archaeological dig," where they had the opportunity to explore items in the dirt while learning about archaeology in Jeffco. The Jeffco table saw over 200 interactions, engaging with parents, kids, and other adults at the information table, discussing the parks, volunteer opportunities, and upcoming events, while distributing maps, stickers, and other cool swag.

Ralston Buttes Hike. In mid-September, guides from Natural Resources led a group from the public on a free, interpretive hike at Ralston Buttes. Ralston Buttes is a highly sensitive, protected area. The guides were able to explain to the visitors about the sensitive natural and cultural resources in the area; they talked about some of the difficult decisions JCOS must make as land managers, when balancing resource protection and recreation. JCOS is planning to lead this hike again next year.

**Trails Symposium Wrap-up.** In late September, the Trails Team headed to Salida for the Colorado Trails Symposium, an annual gathering for agency trail managers. The two-day event allows agency staff to network and share ideas through presentations and field trips. This incredible event had over 120 attendees representing 36 agencies/nonprofits, 13 sessions, four roundtables, and seven second-day site visit options.

Hildebrand Ranch Population Census. The Natural Resources Wildlife Team noted a special visitor, a burrowing owl. They suspect that this individual was making a pit stop after beginning its fall migration. Burrowing owls begin arriving in Colorado from their wintering grounds in late-March or early-April and can be found near their breeding grounds until Halloween, or later. In recent years, some burrowing owls have even begun to overwinter along the Front Range. The Western group of burrowing owls is nearly entirely dependent on burrows dug by other animals; in the plains and intermountain-west the owls are strongly associated with prairie dogs.

**Seed-sational Fall.** The Natural Resources Team has been planting native species that were grown from hand-collected seeds on JCOS property to improve nectar resources for pollinators. Over 4,000 plants were grown in 2024, including shrubs, grasses, and forbs. The Natural Resources Team started the planting effort this fall with wetland species, with planting projects at Van Bibber Park for National Public Lands Day, Elk Meadow Park with internal JCOS staff, and Meyer Ranch Park with JCOS volunteers. Two wildflower species associated with wetlands were planted and include Nuttall's sunflower (*Helianthus nuttallii*) and largeleaf avens (*Geum macrophyllum*).

Local High School Mountain Bike Teams Give Back. Local high school mountain bike teams have been actively working in the parks. A dedicated group of coaches, parents, and student-athletes from Chatfield High School joined JCOS staff for vital, post-fire repair work on the hand-cut fire lines on Meadowlark Trail at Deer Creek Canyon Park, constructing drainage systems on steep lines to prevent water runoff, building a buckn-rail fence at the overlook, and seeding the fire lines. Mountain bike teams from Wheat Ridge and Lakewood High Schools teamed up to tackle a mile of trail maintenance at Apex Park, on the Apex Trail. Athletes from the Golden High School team rolled up their sleeves for heavy maintenance at North Table, on the Mesa Top Trail. Kudos to these youngsters for all their hard work.

Coal Creek Study Area Closed for Hunting. The Coal Creek Study Area is now closed for the 2024 hunting season. Colorado Parks & Wildlife (CPW) set up the hunt camp on October 6; the guided hunter outreach experiences will be happening through November 24. Volunteer Land Stewards have been reminded of the closure and CPW will post warning signs at three gates. Associated vehicles will have park permit hang tags for display. The hunt is coordinated by Pepper Canterbury, Hunting and Angling Coordinator of the Northeast Region for CPW.

**Standley Lake Library Trailhead Ribbon Cutting Ceremony.** On Friday, November 8 at 11:00 a.m., there will be a ribbon-cutting ceremony to celebrate the opening of the Standley Lake Library Trailhead, hosted by the City of Arvada and Jeffco Public Library (JCPL). This trailhead, which was awarded a 2021 Trails Partnership Program grant from Jeffco Open Space, will provide access from the Standley Lake Library, the existing parking area, and Kipling Street to a central public trailhead. From this hub, multiple ADA-accessible routes will lead to the Rocky Mountain Greenway. The

trailhead will also include a central gathering area with an iconic shade shelter, paved plaza, seating, bicycle racks, wayfinding signage, and educational interpretive signage.



South Valley Park has dramatic red sandstone spires and stunning views of craggy outcrops. The trails are well-suited for beginning mountain bikers, and hikers who prefer more level terrain. This park is an on-trail only experience; do not climb on the delicate sandstone formations for your own safety and to protect these highly erosive surfaces. The northwest section of the park is set aside as a Sensitive Area closed to public use to protect nest sites. No off-trail use permitted at South Valley Park.

Van Bibber Park offers an urban get-away as well as a home and migration stop for wildlife. The Van Bibber Creek wetlands provide wildlife habitats, which can be viewed from an observation deck. Visitors enjoy mountain vistas from soft-surface trails that meander through open meadows and a 1.5-mile concrete trail that travels the length of the park and offers accessibility for strollers and wheelchairs.

# **WATCH THIS SPACE...Local Goings-on**

Denver Water is in the process of transferring 45 miles of the 71-mile-long High Line Canal to Arapahoe County. The canal winds through 11 jurisdictions, from Waterton Canyon in Douglas County to northeast Aurora.
